1. Information We Collect

Information You Provide

- Name and contact information (phone number, email address)

- Self-reported mental health history (as provided voluntarily in the intake form)
- Preferred appointment times and contact method
- State of residence

Automatically Collected Information

Like most websites, our site may collect certain technical information automatically, including your IP address, browser type, pages visited, and referring URLs. This information is used only to understand how visitors use our site and to improve its functionality.

2. How We Use Your Information

Information submitted through our contact form is used solely to:

- Respond to your inquiry and determine whether our services are a good fit
- Schedule a consultation or initial appointment
- Communicate with you about your request

We do not sell, rent, or share your personal information with third parties for marketing purposes.

3. HIPAA and Clinical Privacy

Information submitted through this website's contact form is **not** protected health information (PHI) under HIPAA, as no clinical relationship is established through this website. Once you become a client, all clinical records and communications are handled through our HIPAA-compliant practice management platform, SimplePractice, and are governed by a separate Notice of Privacy Practices provided at the start of treatment.

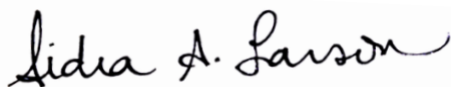
